

Contest/Prize Disclaimer

Washington County Community Action Council, Inc. (the "Company"), will conduct its Costa Rican Treehouse Vacation Raffle (the "Contest") substantially as described in these general contesting rules, and by participating, each participant agrees as follows:

1. Prize. The prize that may be awarded to the eligible winner is not transferable, redeemable for cash or exchangeable for any other prize. The prize must be redeemed/scheduled within 1 year of the contest end date. Scheduling of the prize by the winner is subject to the approval of Finca Bellavista. If a winner cannot be contacted or is disqualified for any reason, the Company reserves the right to determine an alternate winner or not to award that winner's prize, in its sole discretion.
2. Eligibility and Limitations. Participants, the winner, and accompanying guest of the winner must be 18 years or older and currently have or be able to obtain a valid passport if they win. Employees of the Company, board members of the Company, the Contest's participating sponsor (Younger Toyota), and members of the immediate family of any such persons are not eligible to participate and win. The term "immediate family" includes spouses / significant others, children, and any other persons residing at the same household.
4. PR, Publicity, Promotion; Use of Personal Information. By participating in a contest, where allowed by law, all participants and the winner grant the Company exclusive permission to use their names, photographs, voices, and likenesses in connection with promotion of this contest and waive any claims to royalty, right, or remuneration for such use.
5. Release. By participating in the Contest, each participant and winner waives any and all claims of liability against the Company, its employees and agents, the Contest's sponsors and their respective employees and agents, for any personal injury or loss which may occur from the conduct of, or participation in, the Contest, or from the use of any prize.
6. Taxes. Any valuation of the prize(s) stated above is based on available information provided to the Company, and the value of any prize awarded to a winner may be reported for tax purposes as required by law. Each winner is solely responsible for reporting and paying any and all applicable taxes related to the prize and paying any expenses associated with any prize which are not specifically provided for in the official rules. Each winner must provide the Company with valid identification and a valid taxpayer identification number or social security number before any prize will be awarded. Any person winning over \$600 in prizes from the Company will receive an IRS form 1099 at the end of the calendar year and a copy of such form will be filed with the IRS.
7. Conduct, Judging, and Decisions. By participating in the Contest, participants agree to be bound by the decisions of Company personnel. Persons who violate any rule, gain unfair advantage in participating in the Contest, or obtain winner status using fraudulent means will be disqualified. Unsportsmanlike, disruptive, annoying, harassing or threatening behavior is prohibited. The Company will interpret these rules and resolve any disputes, conflicting claims or ambiguities concerning the rules or the Contest and the Company's decisions concerning such disputes shall be final. If the conduct or outcome of the Contest is affected by human error, any mechanical malfunctions or failures of any kind, intentional interference or any event beyond the control of the Company, the Company reserves the right to terminate this Contest, or make such other decisions regarding the outcome as the Company deems appropriate. All decisions will be made by the Company and are final. The Company may waive any of these rules in its sole discretion.
8. Miscellaneous. Void where prohibited. Odds of winning depend upon the number of participants. The Company disclaims any responsibility to notify participants of any aspect related to the conduct of the Contest. All entries become the property of the Company and will not be returned.
